2 HAZARDS IDENTIFICATION

POTENTIAL HEALTH EFFECTS

INHALATION

4 FIRST-AID MEASURES

INHALATION

Unlikely route of exposure as the product does not contain volatile substances. Move the exposed person to fresh air at once. Provide rest, warmth and fresh air. Get medical attention if any discomfort continues.

INGESTION

SKIN CONTACT

HAND PROTECTION

Use chemical resistant gloves. In case of prolonged immersion or frequently repeated contact use gloves made of the materials: butyl rubber (thickness >= 0.36 mm, breakthrough time > 480 min), nitrile rubber (thickness >= 0.38 mm, breakthrough time > 480 min) or neoprene (thickness >= 0.65 mm, breakthrough time > 240 min). For intermittent splash protection corresponding gloves with breakthrough times > 60 min can be used. Avoid gloves made of: natural latex. The protective gloves to be used must comply with the specifications of EC directive 89/686/EEC and the resultant standard EN374.
